



Central Bank of Bangladesh

OPEC backlash: No more oil for the West, but oil for EM

- OPEC and EM cooperation: stand up to the West
- Reforestation (carbon credits) exchanged for oil & gas products
- Setting up an exchange of carbon credits we can sell to Western countries

The Lloyds Syndicate Greenwashing scandal

Central banks take-over ESG funds

- Call for a world conference to address mitigation of climate change events and agricultural needs
- Alert the West on food migration
- Take advantage of the sea rise to generte hydro power
- Create a worldwide insurance system
- Creation of new money back by carbon credits that can be sold as collateral
- Be an intermediary between oil supplier and western countries
- Incentivize the development of renewable energies

Invent remedies


Solutions:

- Green QE to calm markets and direct capital towards transition
- Education of internal staff/leadership of central bank to have climate awareness
 - Education of financial instituation
 - Promotion climate of governance within banks
- Change the mandate of the central bank to not only cover inflation but have wider to ensure orderly climate transition
 - Gardian of the carbon market
 - Asset quality review by banks to capture exposure to climate risks
 - Green RWA
 - Harmonization of disclosure standards gloablly (through NGFS

Invent remedies


Action plan - short term:

- Funding on desalinizations (and others) projects and infrastructures (storage, distribton, ...)
- Investment in self sufficient water systems (roof rain filters), recyled water systems on a very large scale
- Investing in hydroponics, permaculture, agroforestry projects (less water consuming agriculture models)
- Investing in sovereign bonds, to fund social / safety nets: water "bouclier tarifaire"...
- Investor association / lobbying

Action plan - long term:

- Investment in education
- R&D into rain engineering
- VC in decarbonization projects
- Investing into smart cities projects








Invent remedies

For asset managers

short term:

pomoting through standards and labelling investments that support local provision of water, food and green energy supply and promote circular conomy - stop-speculation on commodities - coordinating with other financial watchdogs

long term: increased transparency on sustainability efforts

improved SFDR implementation

for banks

- Green supporting and brown penalising factors to support better factoring in of major systemic risks
- through green supporting factor
- support local provision of water, food and green energy supply and promote circular conomy
- watchdogs to step in to prevent bankruns

- improve collaboration on risks modelling
- support co-insurance pool
- green conditionality for insurance subscription
- refined coordination with public
authorities to maintain affordable
insurance for all to maintain premiums within acceptable boundaries

support blended finance / publicprivate corporates with general interest objectives

reinforce controls on all actions to ensure real implementation + transparency against greenwashing
